Tournament Hotel

The Westin Nova Scotia (“Hotel”) is the official tournament hotel. It is located at 1181 Hollis St, Halifax. The tournament will be held at the Sexton Gym, Dalhousie University, 1360 Barrington St., Halifax, Nova Scotia. The Hotel is a short 2 minute walk to the Friday clinics and the tournament and is within easy walking distance to downtown Halifax, historic waterfront, shopping, restaurants and parks.

The special tournament rate is a \$179.00 for 2 people in a room plus \$20 per additional person. Check-in time is 3:00 pm. Every effort is made to accommodate guests arriving before the check-in time, however rooms may not be immediately available. Check out time is 12:00 noon.

Tournament Venue

All tournament competition will be held at: **Sexton Gym, Dalhousie University, 1360 Barrington St., Halifax, Nova Scotia**, a short 2 minute walk from the Hotel.

A registration desk will be set up at Sexton Gym, between 5:30 pm and 7pm on Friday, May 15 and between 8:30 am and 12 pm on Saturday, May 16. All provincial directors and coaches are asked to check in, verify and confirm the list of their province’s competitors prior to the start of competition on Saturday.

Transportation

Dan Examination - Friday May 15, 2020

The dan examination will be 4:30 to 5:30 pm., Sexton Gym. The examination will be administered by the ISKF Technical Committee Members. Registration procedures are as follows:

- Two copies of the registration form in type (not handwritten), with 2 passport size photographs along with the dan examination fee (US cash or US money order payable to “ISKF NS”) and registration fee (US money order made payable to “ISKF”) as per the international fee schedule (**both exam and registration**). Judges' Seminar and Examinations (written/practical) – Friday May 15, 2020

The ISKF International Judge Examination is in two parts – written exam and practical exam. Pre-requisites for these exams are 22 years of age, and a minimum of second dan. The registration form must be completed by the registration deadline. The judges' registration fee is included in the examination fee.

The cost: **\$80.00** (judges clinic and judges exam) - **\$20.00** (judges clinic only – all qualified judges are expected to attend the clinic)

The King's College Gym building is the second building on the right, after the King's College Library. Parking is available in the rear parking lot between the Gym and the Dal Life Science Building. Go to the entrance of the building that faces the King's College Library. Go downstairs and you will see the dojo.

ISKF Instructors Trainee Class (Subject TBD)–will be held at 7:00 pm on Friday evening in the Sexton Gym. There is no fee for participation in this class if 2 or 3 other classes are attended. 39th ISKF Canada Championship Tournament -

The eliminations and finals for youth and intermediate kyu ranks, eliminations and finals for adult brown belt, Dojo Tournament and Senior Kata & Kumite will be held here. Fee for individual youth and adult (one or more) events are **\$45.00** per contestant. Team events (kata and kumite) are all **\$60.00** per team.

Kyu Shobu Ippon Kumite Tournament

We are excited to continue the free sparring event in the ISKF Canada National tournament for every ISKF member in the green, purple and brown belt (6th kyu to 1st kyu) category. This is a 'demonstration event'. It is a completely voluntary event but all contestants wishing to participate must have first performed their regular ippon kumite competition in the spirit of budo!

Dojo Tournament

We are pleased to continue the Dojo Tournament as we did last year. Each ISKF Dojo is permitted to send up to 2 teams consisting of 3 competitors, brown and black belts, between 18 and 45 years. The team kata (no eliminations, straight to finals) may be a mix of male and female but team kumite will be separated between male and female. We hope that the Dojo competition will allow those who are not competing in the Provincial Teams to experience the excitement and thrill of team competition. Those black belts competing in the Dojo competition may also compete individually in the adult individual competition on Sunday but not on the Provincial Teams.

Individual Competition - Adult Black Belt 45-55 yrs.

Adult Black Belt 45-55 yrs. individual eliminations and finals. Those over 55 yrs. may compete with permission by their Provincial Chief Instructor.

Provincial Team Competition: Each province will be permitted to submit 2 three person adult black belt teams. This applies for kata and kumite for both men and women.
